to two sides of Claimant/allottees including those who want refund of the

amount (may be Principal Amount) and the allottees who wants completion of

the project.

We have noticed submission made on behalf of the Appellant that the

project can be completed within 180/210 days.

Post the appeal 'for orders' on 9th December, 2019.

The interim stay order dated 16th October, 2019 relating to constitution

of Committee of Creditors shall continue till next date.
